Dang Xuan Dieu is an engineer and a social organizer. He is actively involved in causes such as access to education for low-income students, helping victims of hurricanes or disabled persons. He is a citizen journalist and has written various articles for the Vietnam Redemptorist Journal. Sentenced to 13 years in prison, Dang Xuan Dieu suffered ill-treatment in detention. A recently released fellow prisoner says Dang Xuan Dieu is treated as a "slave" by the other prisoners with the complicity of the guards. In August 2013, the UN Working Group on Arbitrary Detention (UNGWAD) recognized the arbitrariness of the detention of Mr. Dang Xuan Dieu, stating that his detention violates several articles of the Universal Declaration of Human Rights, and the International Covenant on Civil and Political Rights to which Vietnam is signatory.

### **Tran Thi Thuy**

Tran Thi Thuy is an activist for justice, both for herself and other victims of forced expropriations in the province of Ben Tre. Ms. Thuy is a faithful Hoa Hao Buddhist and a member of Viet Tan. Tran Thi Thuy was arrested on August 16, 2010 on charges of "subversion's attempts", under clause 2 of Article 79 of the Criminal Code, and sentenced to eight years in prison followed by five years house arrest. Subjected to forced labor and prison brutality, her health deteriorated sharply. Her family is often harassed and brutalized by security force and criminal gangs directed by authorities. In December 2011, the UN Working Group on Arbitrary Detention (UNGWAD) recognized the arbitrariness of the detention of Ms. Tran Thi Thuy, stating that his detention violates several articles of the Universal Declaration of Human Rights, and International Covenant on Civil and Political Rights to which Vietnam is signatory.

Ho Duc Hoa is a social organizer and has written articles for the Vietnam Redemptorist Journal. A member of the Vinh Diocese, Hoa is also a member of the John Paul II Group for Pro-Life and was actively involved in causes such as access to education for low-income students, assistance to victims of hurricanes or disabled persons.

He was arrested as part of a large-scale crackdown totaling 17 human rights activists (mostly from the Vinh Province). In August 2013, the UN Working Group on Arbitrary Detention (UNGWAD) recognized the arbitrariness of the detention of Mr. Ho Duc Hoa.

### Nguyen Dang Minh Man

Nguyen Dang Minh Man is a social activist and a photo journalist. She took and posted pictures showing the slogans "HSTSVN", initial Vietnamese letters for "Paracel & Spratlys belong to Vietnam".

After attending a seminar on non-violent struggle organized by Viet Tan, she was arrested and convicted with 13 others. Despite the number of people in the dock, their trial lasted only two days. Minh Man was sentenced to 8 years in prison, and five years house arrest. In October 2014 the English Media Legal Defence Initiative NGO, and Oxford University have submitted a complaint to the UN Working Group on Arbitrary Detention (UNGWAD) to protest against the arbitrariness of the detention of Miss Minh Man.

### Nguyen Van Dai

Since his arrest, his wife Vu Minh Khanh has not been allowed to visit him but has recently been able to send supplies to him. In December attorney Ha Huy Son submitted the paperwork to become Dai's defense lawyer but was declined by the Ministry of Public Security.

Nguyen Van Dai is a human rights lawyer and a blogger. He founded the Committee for Human Rights in Vietnam in 2006, dedicating his life to civil empowerment through legal means with programs aimed at expanding legal networkings, building capacity for future human rights defenders and increasing legal education by disseminating and authoring publications on civil and legal rights.

Dai also founded the "Brotherhood for Democracy" in May 2013, a group of mostly former jailed dissidents to co-ordinate mobilising efforts throughout Vietnam.

Dai was previously tried in May 2008 and sentenced to five years in prison (later reduced to four years) for "conducting propaganda against the state" (Article 88) and was forced to close his offices. He was released to four years of house arrest on March 9, 2011 and disbarred. Dai concluded his house arrest in March 2015 but experienced regular police harassment, physical attacks and surveillance.

Dai was the recipient of Human Rights Watch's Hellman-Hammett Award and Vietnam Human Rights Network's Human Rights Award in 2007.

Le Thu Ha is the secretary of the independent organization, the Brotherhood for Democracy Association. Currently, it is not known whether she has been formally charged.

Lê Thu Ha had been arrested on 23 September with four other staff members of the independent Lurong Tâm (Conscience) TV, set up in August 2015 to broadcast short video clips on YouTube about human rights issues in Viet Nam. She was an English translator for the broadcasts. Ha Noi security police held the five for questioning until late in the evening.

Activists tried to visit Lê Thu Hà at B14 prison on 20 December, but were not authorized to visit. She is at risk of torture and other ill treatment. Human rights defenders facing criminal charges are subject to severe and often brutal treatment during pretrial detention and investigation

Tran Huynh Duy Thuc was a former manager of the internet company OCI. In 2005, with others such as Le Thanh Long, he created a group of Chan study on the political and social situation in Vietnam.

In November 2008, he created two blogs: Change We need and Tran Dong Chan where he published articles and columns about the leaders of the political regime.

In March 2009, he went to Phuket, Thailand, to meet other democracy activists in order to create political organizations capable of replacing the Vietnamese Communist Party when the situation requires it. When he returned to Vietnam, he was accused of having founded the Socialist Party of Vietnam.

On 24 May 2009, Tran Huynh Duy Thuc was arrested under the initial charge of "promoting antigovernment propaganda" under Article 88 of the Vietnamese Criminal Code for peacefully exercising his right to freedom of expression. On 20 January 2010, in a one-day trial, Tran Huynh Duy Thuc and his three co-defendants – Le Cong Dinh, Nguyen Tien Trung and Le Thang Long – were prosecuted at the People's Court of Ho Chi Minh City for "conducting activities aimed at overthrowing the people's administration" under Article 79 of the Criminal Code. Thuc was sentenced to 16 years' imprisonment followed by 5 years of house arrest, while Dinh, Trung and Long, were sentenced, respectively, to 5 years, 7 years and 5 years' imprisonment followed by 3 years of house arrest.

On 29 August 2012, the United Nations Working Group on Arbitrary Detention (WGAD) adopted the opinion that Thuc and his three co-defendants' detention violated the right to freedom of opinion and expression guaranteed by Article 19 of the International Covenant on Civil and Political Rights (ICCPR), as well as the right to liberty and security of person (Article 9) and the right to freedom of association (Article 21), to which Vietnam is a party.

## Franz Jessen, European Union ambassador in Vietnam, January 11, 2013 :

the EU Ambassador in Vietnam, Franz Jessen, expressed concern about sentences ranging from 3 to 13 years handed down prison on January 9 in the province of Nghe An, against 14 bloggers and journalists, for acts related to the exercise of freedom of expression.

Jessen recalled the fundamental right of everyone to freely express their opinions in a peaceful manner in accordance with the Universal Declaration of Human Rights and Article 19 of the International Covenant on Civil and Political Rights, to which Vietnam is a party.

He added that this sentence appears to be incompatible with the international obligations of Vietnam»

## European Parliament Resolution (2013/2599(RSP) of April 18, 2013 :

Expresses its deep concern about the conviction and harsh sentencing of journalists and bloggers in Vietnam; condemns the continuing violations of human rights, including political intimidation, harassment, assaults, arbitrary arrests, heavy prison sentences and unfair trials, in Vietnam perpetrated against political activists, journalists, bloggers, dissidents and human rights defenders, both on- and offline, in clear violation of Vietnam's international human rights obligations; [...] »

### Rupert Abbott, Amnesty International, 9 January 2013 :



« The charge of attempting to overthrow the government is without

merit, and these people were detained solely for exercising their right to freedom of expression. We call on the Vietnamese authorities to release these activists immediately and unconditionally»

### ACAT – Urgent Call for Ms Tran Thi Thuy, 20 March 2014 :



« Land rights activist, Ms. Tran Thi Thuy, 42, has been arbitrarily detained since 2010. She is, moreover, deprived of medical care and is subjected to very harsh prison conditions. Currently detained at the prison of K5 Xuan Loc camp in Dong Nai province (in the south), she remains subject to forced labor. She should dry fifty kilos of fish per day backbreaking work. Following

several fainting, a medical examination in autumn 2013 showed that her spine was calcified and had calculations of the gallbladder

### Front Line Defenders – Dang Xuan Dieu, social activist, severely mistreated in jail, 15 October 2014 :

« The first detailed information on Dang Xuan Dieu of prison abuse were made public on Oct. 7, 2014, when his former cell mate, Mr. Truong Minh Tam, was released. Mr. Truong Minh Tam said Dieu is treated as an "animal" and a "slave" in prison. Each cell is normally between 6 and 8 square meters, and prisoners are sometimes chained in pairs. Mr. Tam reported that during summers, prison authorities put more prisoners in the cell of Dang Xuan Dieu, making it difficult to breathe with the warmth atmosphere. While in winter, Dang Xuan Dieu finds himself alone in his cold cell.

According to information received, sometimes Dang Xuan Dieu is deprived of toilet paper. Feces were often deliberately left in his cell for several days, creating an unhealthy and unbearable smell. Reportedly, the human rights defender was forced to live and sleep next to their feces. He was not allowed to have regular showers or brushing teeth »

## Global Voices – a citizen photojournalist in prison hunger strike, 11 December 2014 :



Front Line

« Nguyen Dang Minh Man was arrested there over three years for taking photographs during a protest and sentenced to eight years in prison for subversion.

She is currently serving his prison sentence in Camp No. 5, Yen Dinh in Thanh Hoa province. The conditions are harsh, and she is subject to heavy physical labor. On November 16, 2014, Minh Man and three other prisoners of conscience have been placed in segregation for unknown reasons. On November 28 2014, Minh Man began a hunger strike to protest against this unfair treatment »
